




### Audience in Numbers

## US-Africa Partnership: Key Highlights

# General Sponsor Sun Africa sets ambitious tone at official opening in Washington D.C.



Speaking to a room filled with government officials, investors, and policymakers, Rajiđić announced that Sun Africa is close to finalising its first commercial agreement with the Government of Nigeria: a \$2.4 billion integrated energy project. He called it a pilot, but quickly made clear that it is only the beginning.

“We also signed a \$10 billion framework agreement with the government in the next year to electrify an additional 50 states,” he told delegates, drawing attention to the scale of what lies ahead.

The announcement set a striking tone for the summit, which is designed to explore and strengthen U.S.–Africa ties in the energy sector. While panels and discussions touched on finance, policy, and technology, it was Sun Africa’s presence that gave the opening session its spark.

Rajiđić outlined projects soon to be unveiled in Tanzania and the Democratic Republic of Congo (DRC), along with a partnership involving the Government and King of Lesotho, a country he suggested would soon be better known to U.S. stakeholders through its energy ambitions.

But beyond the figures, it was Rajiđić’s personal connection to Africa that seemed to resonate in the room.

The 10<sup>th</sup> Powering Africa Summit opened in Washington, D.C., with a sense of momentum and high expectations. At the centre of it was Sun Africa, the event’s general sponsor, whose founder, Goran Rajiđić, used the stage to lay out a bold vision for energy partnerships between Africa and the United States.

“We are not visitors to Africa,” he said. “My wife is Angolan. I have 200 family members in Africa.”

It was a reminder that Sun Africa’s positioning is not only commercial but also relational, grounded in a sense of belonging on the continent. That mix of personal narrative and large-scale investment strategy positioned the company as more than just another player in the African energy space — but as a bridge in the evolving U.S.–Africa partnership.

As the summit continues, Rajiđić’s opening words are likely to frame much of the discussion: Africa’s energy future is not only a matter of policy and finance, but also of trust, continuity, and vision. And Sun Africa, at least this week, made sure it was seen as carrying all three.

# U.S. Secretary of Energy Chris Wright outlines new administration approach to energy development in Africa

U.S. Secretary of Energy Chris Wright outlined the Trump administration's approach to energy development in Africa. The United States will embrace energy from a diversity of sources – from coal to natural gas to nuclear power to solar energy – to increase access across Africa, said U.S. Secretary of Energy Chris Wright on Friday.

**D**uring the Powering Africa Summit, Wright said the new U.S. administration would partner with African governments and businesses, allowing them to drive their own energy agenda to increase economic growth and prosperity around the continent. "The only goal of energy is to expand human opportunity. Make us live longer. Healthier. More opportunities for us and our kids. Increase food security. Increase heating security. It's foundational," Wright said.

Africa needs massively more energy. Africans will do that. Africans will deliver that. The United States is thrilled to partner with you in that endeavour." The U.S. will not put limits on the type of energy projects it will finance, Wright said, noting that "there's no technology I don't like." "How can we harness that entrepreneurial spirit with some technology assistance, lower-cost capital from the United States, to make things happen? We don't have a top-down grand plan," Wright said. "We're not going to decide what you want. You decide what you want. Your citizens, your people, decide what they want. We want to be your technology partners and provide capital and partner in any way we can to pursue that goal."

Nigerian Minister of Power Adebayo Adelabu credited Powering Africa Summit with fostering critical discussions

and catalysing partnerships to transform Africa's energy landscape, which includes mobilising investments, making policy reforms, and expanding access to stable, functional, and reliable electricity on the continent.

"In Nigeria, Power Africa has played a pivotal role in supporting our approach of policy reforms, infrastructure development programs, leveraging bilateral funding to derisk investments, sector commercialisation, and strategic partnership with the investment community," Adelabu said. "The presence of strong U.S.-Africa collaboration has not only improved infrastructure, it has also stimulated growth and job creation." "Energy poverty isn't solved by wishful thinking. It's solved by power plants that come online as quickly as possible. The focus must be on large-scale projects, reducing the lengthy and bureaucratic processes that hinder progress. And by unleashing U.S. private enterprise by eliminating hurdles contrary to achieving our goals," said Sun Africa Chief Executive Officer Adam Cortese.

"The administration's all-in-one energy strategy is the backbone of this vision. A practical, no-nonsense plan that embraces every tool in the toolbox to deliver results."

Together, the speakers underscored the urgency, partnership, and scale needed to expand reliable energy access across Africa.



## US-Africa Partnership: Key Highlights

# African Ministers Stress Partnerships to Drive Energy Expansion



**L**iberia's Vice President Jeremiah Kpan Koung reported a 31% increase in access, credited to Power Africa, and highlighted plans to grow hydro, solar, and wind while advancing regional trade. Nigeria's Minister of Power, Adebayo Adelabu, presented a \$32.8 billion investment plan to achieve universal access by 2030, focusing on metering, grid reliability, and stronger coordination with partners such as the World Bank and DARE programs.

Egypt's Petroleum and Mineral Resources Minister Karim Badawi reaffirmed a 42% renewables target by 2030. Botswana's Minister of Minerals and Energy, Bogolo Kenewendo, stressed the importance of innovative financing and technology transfer to deliver nationwide connectivity. Zimbabwe emphasised legal reforms and incentives for hydro, solar, and gas projects, including the

Batoka Gorge initiative. Eswatini set a goal of generating 70% of its own power, while The Gambia laid out plans for universal access by 2026 through grid expansion and a 150 MW solar plant.

Sierra Leone showcased a \$412 million gas-to-power project and Millennium Challenge Corporation compact that has doubled capacity and aims for 80% electrification by 2028.

Closing the session, Dr. Kandeh Yumkella emphasised the importance of regional collaboration, linking energy to industrialisation and climate resilience, and fostering inclusive partnerships.

The session ended with a clear call: increase investment, deepen cooperation, and accelerate Africa's energy progress.

## US-Africa Partnership: Key Highlights

# Mission 300: Powering 300 million Africans by 2030

Access to electricity remains one of Africa's most significant challenges, with nearly 600 million people—half the continent's population—still living without it. The continent accounts for 83% of the global electricity access deficit, highlighting the scale of the problem.

**T**o address this, the World Bank Group and the African Development Bank Group, alongside international and regional partners, launched Mission 300, an ambitious initiative to bring electricity to 300 million Africans by 2030.

### Momentum and Commitments

In Dar es Salaam earlier this year, 30 countries endorsed the Dar es Salaam Declaration, committing to policy reform, regional integration, and universal access to electricity and clean cooking. Twelve countries presented National Energy Compacts with clear targets for expanding renewables, electrification, and transforming utilities.

Financial backing is significant: the World Bank has pledged \$30 billion, the AfDB \$18.2 billion, with further support from the Islamic Development Bank, the Asian Infrastructure Investment Bank, the OPEC Fund, and others.

### Clean Cooking at the Core

Mission 300 goes beyond electricity. Access to clean cooking is a priority, with Tanzania planning to distribute 2.4 million e-cooking stoves by 2034 and Sierra Leone aiming for 80% electrification and up to 40% clean cooking access. Leaders emphasised that energy access and clean cooking must advance in tandem to improve lives and health outcomes.



### Collaboration that Sets Mission 300 Apart

At a recent gathering in Washington, D.C., stakeholders emphasised the initiative's unique collaborative model. Valerie Levkov of IFC highlighted new financial instruments—such as local currency facilities and long-term working capital—that are helping to overcome affordability barriers, particularly in rural areas.

Woochong Um, CEO of GEAPP, underlined the role of philanthropy in de-risking projects and catalysing investment. At the same time, Sierra Leone's H.E. Dr. Kandeh Yumkella emphasised the importance of national ownership and political will.

Together, these elements—political leadership, private sector investment, development finance, and philanthropy—are what make Mission 300 a truly transformative effort. If successful, it will bring life-changing electricity access to millions and mark a turning point in Africa's energy future.
